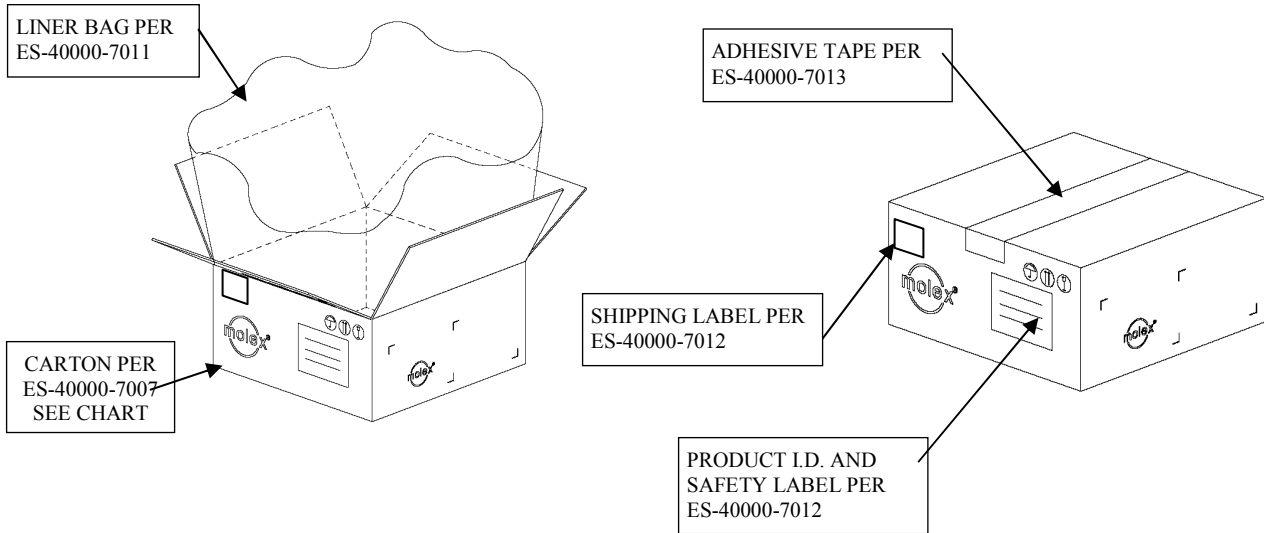




PACKAGING SPECIFICATION



- 1) CARTON BOTTOMS CLOSED WITH STAPLES, TOPS TO BE SEALED WITH A 2" WIDE ADHESIVE TAPE PER ES-40000-7013.
- 2) BAGS LINE THE APPROPRIATE BOX AND MAY BE CLOSED WITH A REUSABLE CLIP.
- 3) MOISTURIZATION ON PARTS WHEN NOTED. DEIONIZED WATER APPROXIMATELY, 2% BY WEIGHT PER BAG.
